



INTERROGATE YOUR EVIDENCE


- Ask questions in conversational language and receive an answer crafted only from the evidence in your DISCO Ediscovery database
- View the cited documents and the specific, highlighted passages that were used to generate the answer
- Scope Cecilia Q&A to a subset of your documents to control the information Cecilia Q&A considers when answering questions
- Stop constructing complex search queries and combing through hundreds of documents — instead, ask questions directly and get answers in seconds.

DIG DEEP INTO INDIVIDUAL DOCUMENTS

- Use with Cecilia Q&A and doc summaries to supercharge your review workflow



- Quickly grasp key documents identified by Cecilia Q&A to speed your understanding of the case






CECILIA AUTO REVIEW

- Drastically reduce the time and cost of using human reviewers



BUILD A STRONGER CASE FASTER

- Upload a case document to automatically generate a timeline with succinctly summarized key facts and the linked, highlighted document from which each fact was pulled
- Continue to add to your timeline as more documents become available over the course of a case
- Use generative AI to provide your case team or client with an organized view of the up-to-date, chronological, relevant information for the case
- Understand and communicate the chronology to assess the strength of the case, prepare for witness examinations, or tell a persuasive story at trial

UNDERSTAND AND LEVERAGE TESTIMONY IN MINUTES

- Upload a deposition transcript into DISCO Case Builder to get a digest of key points, with links and citations to the transcript

JUMPSTART THEORY OF THE CASE

While working on a particularly complex matter, one client uploaded a complaint into Cecilia auto timelines and received dates and summaries, with citations, of the key events alleged by the complaint – without doing any manual work themselves. Seeing the ease, speed, and value of Cecilia auto timelines, along with the integration with DISCO Ediscovery, we've had law firm partners ask where Cecilia has been all of their lives.

UNDERSTAND COMPLEX ISSUES

One firm spent weeks looking for evidence demonstrating actual corporate control, but kept coming up empty-handed with traditional search terms. When they got access to Cecilia Q&A, the document that had eluded them for so long was unearthed in hours. Cecilia Q&A understood that "control" could be demonstrated even without that word appearing in the document text. The firm said that Cecilia Q&A unlocks legal issues that are "very hard to prove using conventional search methods."

PLAY BETTER DEFENSE

In very contentious case, law firms have used Cecilia Q&A on their own outgoing productions. They copy-and-paste each allegation from the complaint into a Cecilia question to identify all of the documents they have to contend with. This allows them to predict and start defending against the plaintiffs' best arguments.

INVESTIGATE DIFFICULT ISSUES

An Am Law 50 firm used Cecilia Q&A on a case involving millions of records. The firm needed to find documents showing misconduct, but the behavior was too generic to be described with search terms. Within the first few questions to Cecilia Q&A, the ediscovery team found an email stating that the problem had occurred and one party knew about it.
